YOUR PLACE FOR BUSINESS DEVELOPMENT

The city Spišská Nová Ves is part of the Kosice region.

Number of inhabitants (mainly of Slovak nationality) by 31. 12. 2011 was totally 37 000 people on the area of 66.67 km. Spišská Nová Ves lies 452 m above sea level and the Hornad river flows trought the town. The district is characterised by a concentration of business activities as most of all economic activities are centred right in Spisska Nova Ves. In terms of national strategic documents, Spišská Nová Ves is one of five innovative poles of growth of the Kosice region what confirms its potential of a suitable city for development of business.

The city has a number of suitable facilities for organizing conferences, workshops, symposia as well as specialized exhibitions and expositions. The city and its surroundings offers quality accommodation and catering facilities.


Healthcare is provided by the Hospital and by network of public and private ambulances.

The city offers a wide range of sports facilities, such as the ice-stadium, indoor and outdoor swimming pools, sports hall, tennis courts, fitness centres, and riding-hall. Rich cultural life in the town ensures permanent scene of Spiš Theatre, Spiš Art Gallery, Municipal Cultural Centre and Spiš Museum. Near the town Spišská Nová Ves is situated National Park of Slovak Paradise known by rock formations, underground caves and waterfalls which create beautiful scenery.

SELECTED DEMOGRAPHIC AND ECONOMIC INDICATORS

Population and average age

Population of the town by 31. 12. 2011 was 36 959. Average age of inhabitants is 37 years, 74 % of the population is at productive age.





In term **of road connection**, Spišská Nová Ves is situated on the intersection of two important second class roads directing all traffic right to its center. Estimated distance of the town's connection on D1 motorway (connects Bratislava with border crossing Záhor on state border with Ukraine through Trnava, Trenčín, Žilina, Poprad, Prešov, Košice and Michalovce) will be 7 km in the direction to Levoča and 15 km in the direction to Poprad by road no. 536 behind Spišský Štvrtok 15 km from the town.

Train connection – the town lies on railway corridor no. V.a from Bartislava trough Žilina – Košice – Čierna nad Tisou to Čop, whereby main branch runs from Venice to Lvov. **Air transport** can be reached by the nearby airports with international status Poprad-Tatry (25 km) and Košice (75 km). Sports airport with the possibility of landing of private airplanes and helicopters is also located in the town.

UNEMPLOYMENT

Number of unemployed registered in Labour Office, Social Affairs and Family by 30. 11. 2011 was 2 682 with an unemployment rate estimated up to 14 %. The largest group of unemployed - 27 % is at the age of 26-35.



EXPECTED GROWTH

Town Planing Scheme of the town Spišská Nová Ves (www.spisskanovaves.eu) deals with areas in cadastral area of Spišská Nová Ves in more detail. Currently, the most recent and the most used is **Industrial Park** on Drevárska Street and

Industrial zone Podskala.

Both localities are part of brownfields situated in south-eastern part of the town Spišská Nová Ves having complete technical equipment. Industrial area of Embraco Slovakia is situated north-east from places of interest. Its surrounding has potential for industrial use on unbuilt urban areas as perspective greenfield. Expansion of economic activities within the town is planned with further areas - 60 ha, and 90 ha to the end of the year 2030, that are privately owned.
